Expression of Interest (EoI) is invited from publishers of books to publish the books and publications of the Council. The publisher will be responsible for the printing, distribution, marketing and selling of these books and journals.

Publishers engaged in the publication of books related with civil engineering, building materials & construction technologies/systems and housing in general with ten years experience in publishing industry with min 600+ tiles back list and an average annual turnover of more than Rs.1 Crore per annum in the last three years can apply, offering their terms and conditions. The publisher has to ensure high quality publication in terms of quality of paper, printing, binding, book jacket, design, proof reading and overall book layout and Should have in-house team for all the work related to publishing of the book to ensure quality and timely publication to the satisfaction of the Council.

The publication of such books shall be in the name of the Council and the Council as well as the publisher shall have copyrights. The Council may use the books or any part of any of the books in any form for non-commercial purposes. The publisher shall be the collaborator 'Publishing House'. The publisher has to also ensure publication adhering to the deadlines specified by the Council. Publisher will have worldwide selling right of print & eBook.

The Council shall buy required number of copies of each book from the publisher at a discounted price for its own use, including distribution among stakeholders. The published price of the books should be comparable to the price of similar book or textbook.

The EoI must be submitted in two sealed envelopes, containing a brief proposal clearly indicating the profile of the publisher, its organisational structure along with the availability of in-house facilities for undertaking the task, its experience in publishing books related to civil engineering, details of the projects undertaken in past ten years, qualifications and experience of the team that will be undertaking the task, and other details elaborating on its capacity to undertake the work (**Annexure I**). The envelope No. 1 will be superscribed as '**Technical Bid**'. The other envelope No. 2 will be superscribed as '**Financial Bid**' and shall contain the financial terms and conditions for publishing these books/publications as well as the percentage of royalty offered to the Council (**Annexure II**).
